**NOTICE OF PROPOSED ROAD HUMPS AND RAISED TABLE ZEBRA CROSSINGS ON
NORTON ROAD, THURSTON**

Suffolk County Council proposes to construct two raised table zebra crossings and round top road humps on Norton Road, Thurston. The two raised table zebra crossings will be located on Norton Road, one shall be located 25 metres west of its junction with Sandpit Lane, and the other 16.5 metres east of its junction with Pond Field Road.

Suffolk County Council also proposes to construct the following road humps on Norton Road, Thurston:

- One partial width round top road hump 70 metres west of the junction with Sandpit Lane, which will be 3.7 metres long and 75 millimetres high;
- One full width flat topped road hump 25 metres west of the junction with Sandpit Lane, which will be 6 metres long, 75 millimetres high, and will include ramps measuring 1.125 metres;
- One partial width road top road hump 20 metres east of the junction with Sandpit Lane, which will be 3.7 metres long and 75 millimetres high;
- One partial width round top road hump 28.5 metres west of the junction with Pond Field Road, which will be 3.7 metres long and 75 millimetres high;
- One full width flat topped road hump 16.5 metres east of the junction with Pond Field Road, which will be 6 metres long, 75 millimetres high, and will include ramps measuring 1.125 metres; and,
- One partial width road top road hump 61.5 metres east of the junction with Pond Field Road, which will be 3.7 metres long and 75 millimetres high.
