The current surface is broken and worn in places, by resurfacing it, not only will it become a safer place for young families and under 12's to enjoy, it will also bring it in line with current critical fall height guidelines.</p> <p>It is understood that there is £6025.40 of S106 monies due to Thurston, and an application has been made for this sum.</p>

Therefore a significant increase in families using the play facilities is expected.</p>
